This event is limited to sports cars only: generally this is a roadster but waivers may be granted if the vehicle compliments the Car Show Extravaganza theme as determined solely by The Kalamazoo Miata Club Chairmen. No mail-in registrations will be processed after May 15, 2010. There is no selling or advertising of any kind allowed in a vehicle registration space. Registrations are Non-Refundable and Non- Transferable. I understand that I assume all risk for loss, theft, damage, liability, injury, cost or expense that I may incur during any of the events presented by Kalamazoo Miata Club, US-31 MotorSports Park and Otsego Barber Shop, and further agree that I will save, defend and hold harmless, Kalamazoo Miata Club, US-31 MotorSports Park and Otsego Barber Shop, and their Directors, Officers, Employees, volunteers and agents from any claims, loss liability, damage or cause of action, including attorneys fees, that I may incur, suffer or be required to pay in the course of my participation as a participant, exhibitor or volunteer at any of the events and activities held.
